NATIONAL AUCTION SELLING COMMITTEE (NASC)

MEETING 4TH MARCH 2005

SUMMARY OF OUTCOMES

5.0 CHAIRMANS PAPER – COMMITTEE PROTOCOL

5.1 Agenda Items

It was AGREED that all formal Agenda Items must be submitted in writing. Items without supporting literature would be considered under Other Business.

5.2 Confidentiality

The paper canvassed the preference to keep Papers confidential. Members thought that this may inhibit the consultation process.

It was therefore AGREED that Papers for each meeting were to be distributed to the Committee members only. Committee members may then, at their discretion, release papers to constituents as part of the consultation process. Only Papers expressly marked with an Embargo statement would be subject to the Embargo condition.

5.3 Alternates

It was asked whether Alternates could be variable.

The Committee AGREED that the Alternate should be known and non variable.

5.4 Voting

The Committee AGREED with the Chairman's Paper, namely:

- Wherever possible, agreement on a recommendation is achieved by consensus, without counting votes.
- If a vote is necessary, only the decision is noted in the Minutes, not the vote count.
- If a vote count is deadlocked, the Chairman (who has no voting right) may defer resolution of the issue to the next meeting, allowing more research/consultation to be conducted before the issue is brought forward again.
- If, after discussion by Members within the Meeting, more detail on any agenda item is required before the Committee can make any agreement on a recommendation, the agenda item will be deferred for further discussion at the next Meeting. The Secretariat will initiate further research and consultation, as appropriate. Two Committee members will be nominated as contacts for the Secretary to monitor progress in this process.
- Where an in-principle agreement is made on an Agenda Item, but implementation requires some detail to be finalised, this will be delegated to the Secretariat. Two Committee members will be nominated as contacts for the Secretary to monitor this process and accept it on behalf of the Committee.

5.5 Spokesperson

- The Committee AGREED that unless a spokesperson was specifically designated, Committee Members could comment on local issues. The Member would need to be cogniscent on whether they are representing the Committee or their own position.

6.0 SALE ROSTER

6.1 Wool Selling Program (WSP)

The Committee considered DRAFT Wool Selling Programs (2005-06, 2006-07).

Two options were selected and the decision on the WSP deferred to a telephone conference on the 14th March 2005.

At that conference the Committee AGREED to release OPTION 1 as the WSP for 2005/06 and similar template for 2006/07.(Attached)

ACTION *Secretary to reissue Wool Selling Programs.*

6.1.1 Newcastle Selling Brokers

The Committee AGREED that a Newcastle sale would not be included in the 2005/06 WSP in Week 28, 29th May 2006.

ACTION *Secretary to write to Newcastle Wool Selling Brokers advising of decision*

6.2 Technical Parameters

A summary of Regional Technical parameters were considered. Committee asked for some editorial presentation change.

ACTION *Secretary to edit Technical parameters.*

6.2.1 Local Rostering Issue Resolution protocol

It was AGREED to adopt the proposal in relation to resolving local rostering issues:

- A. If the AWEX representative/administrator finds an issue in Rostering that is not covered in the relevant policy documents (Technical Parameters) then:
1. The local AWEX representative/administrator shall mediate with the sellers/buyers involved.
 2. If this does not resolve the issue, 2 (local) NASC committee members shall be included in mediation, and/or,
 3. On the recommendation of the 2 NASC members or AWEX representative/administrator, the subject shall then be raised at a full meeting of NASC where a decision shall be made.
- B. If an AWEX member has a concern about Rostering they may raise the issue directly with NASC in writing to their representative or the Secretary.

Appeals

Appeals are to be made in writing to the NASC Secretary for consideration by the Committee.

6.2.2 ACWE Uneven Offering Concern

The Committee AGREED that Southern Sellers should review the lot allocation formula to determine if offer flow can be improved and to explore the potential for more selling by separation in Launceston to reduce the shock of the following week.

ACTION *Southern NASC committee members to convene meeting of local sellers and report back at next NASC meeting.*

7.0 REOFFERS WITHOUT SAMPLE

The Committee considered background literature in relation to the proposal to trade reoffers without displaying a grab sample.

The Committee AGREED not to implement a trial at this time.

ACTION *Secretary to write to NCWSBA advising of decision.*

8.0 LODGEMENT OF TRANSFERS

The Committee considered a request that Transfers be lodged within 30 minutes of last Australian Seller on a NZ Merino selling day.

The Committee AGREED that Southern Buyers lodge their transfers within 30 minutes of the last Australian Seller (in either Room) when New Zealand Merino sell last.

ACTION *Secretary to advise Southern Wool Buyers, Roster Administrator, and amend Southern Region technical parameters.*

9.0 AUCTION CATALOGUE (EARLIER TRANSMISSION)

The Committee AGREED that the sellers should be encouraged to transmit an advance copy of the catalogue in much the same manner as pre-release of hardcopy catalogues. The "provisional" catalogue would be provided and accepted only on the basis that it may be incomplete and errors may be expected (E&OE).

ACTION *Secretary to advise Sellers of recommendation.*

10.0 MAXIMISING SELLING DAYS

The Committee AGREED that there was insufficient support for such a proposal to be trialed at this time.

ACTION *Secretary to write to NCWSBA advising of decision.*

11.0 OTHER BUSINESS

11.1 Bale, Test, Sampling Site Security

Determined as outside of NASC Terms of Reference.

ACTION *Secretary to write to Sellers advising of Committee recommendation.*
